# OPEN DOOR CLASSIC

## WAIVER OF LIABILITY, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT

1. In consideration for receiving permission to participate in the Open Door Community House, Inc.'s OPEN DOOR CLASSIC WALK AND 5K RACE, I, the undersigned PARTICIPANT, hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, OPEN DOOR COMMUNITY HOUSE, INC., and its members, managers, directors, shareholders, officers, agents, servants, volunteers and employees (hereinafter collectively referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, that may be sustained by me, or any of the property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the property where the activity is being conducted.

2. I am fully aware of the risks involved and hazards connected with the OPEN DOOR CLASSIC WALK AND 5K RACE. I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in such a program, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.

3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in the OPEN DOOR CLASSIC WALK AND 5K RACE, WHETHER CAUSED BY ME OR THE NEGLIGENCE OF RELEASEES or otherwise.

4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representatives, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE of the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Georgia.

5. I understand that at this event and/or its related activities, the Participants may be photographed. I agree to allow the photos, videos, or film likenesses of me to be used for any legitimate purpose of the event holders, producers, sponsors, organizers and/or assigns.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
